



SECRETARY'S REPORT



Dear Members and Well-wishers,

On behalf of MESCO, it is my honour to present the 53rd Annual Report of the Organization. Before I start, let me express my deep condolences and gratitude to the family members of our Late President Dr. Azhar Ali Qureishi, one of our Founding member Late Mr. Safarali Panjwani and our advisory committe member Mr. Hilaluddin Shaikh, who left for their heavenly abode during the last financial year, leaving behind a legacy for us to carry forward. In the reporting year, due to COVID-19 pandemic and the lockdown there were many set backs to us and our beneficiaries. But, thanks to your support, we could sail through. The pandemic taught us many lessons, we struggled hard to remain connected with our Staff, Donors and the Beneficiaries. Our Staff very rapidly adapted to the new online mode and worked day and night to keep the lamp burning in many houses. Our Clinics had a very severe impact and we were forced to shut down two of them and could serve only 957 patients from Mumbra Clinic.

With your generous contribution we were able to serve 6934 Beneficiaries which include 4167 Educational Scholarships, 212 patients assisted, 148 Sewing Machines distributed to Empower Women and 330 families were provided Monthly Ration Support. During the COVID lockdown crisis we took the initiative to reach out to the families affected financially. We provided dry ration kits and Iftar kits to 1120 families, supported financially School Teachers and Students to take care of their family needs and also paid School fees to prevent drop outs. We also contributed Rs. 50,000/- towards Chief Minister's Relief Fund for COVID. As if the COVID crisis were not enough, the people of Kokan were affected by Cyclone and we extended our helping hand to rehabilitate them.

FINANCIALS

Our total income in the year was INR 9.21 Cr. and INR 1.03 Cr have been received towards Corpus; the expenditure for the corresponding period has been INR.8.73 Cr. Our efforts to tap CSR fund provided us INR. 88 lakhs from corporates which included the likes of M/s.Nadiadwala Grandson Entertainment Pvt. Ltd., M/s.Zarhak Steels Pvt. Ltd., M/s. Wallem Ship Management (India) Pvt. Ltd., M/s.Regent Assets Consultancy Services Pvt. Ltd., M/s.Gold Crest Corporation Ltd. and M/s.Talib & Shamsi Construction Pvt. Ltd. We continued getting support from Give India under various listed donation options; the total amount received was INR.15.18 lakhs. Payroll giving yielded INR.5.48 lakhs and has potential to increase several folds. Sale of old newspapers, clothes and scarp donated yielded INR.13.16 Lakhs. The pandemic had a major impact on newspaper income as the collection was not allowed during pandemic.

MESCO'S PROGRAMS & SCHEMES EDUCATION

MESCO continued its support for the students under various education schemes. These included the general scholarships (2276 under school level, 1063 under college level, 44 for technical courses and 57 for short term vocational courses), scholarships for means deprived and meritorious students (510) and scholarships for professional courses (217). What makes us proud is that out of the total 4167 students covered under these various schemes a total of 50.81% were girls. Apart from the monetary support to these students, MESCO also provided some key inputs like, extra financial support for attending coaching classes, Group and individual Counselling, and focused online webinars and talks. This year special efforts were put in to guide students for future opportunities, webinars were conducted on different topics such as career in medical field, basic calligraphy session, the scope of Engineering and admission procedure, how to prepare for exam etc. apart from these, webinars were conducted to develop the overall personality of our students on topics such as stress management, behaviour management, conflict management, group dynamics and team building, communication skills, time management, leadership, value and respect.

From the last 24 years MESCO has adopted the R. C. Mahim Municipal School under the MCGM PPP Program. The pass percentage at SSC was 100 % with the highest percentage of 89% at the exam. Due to pandemic schools were not allowed to open therefore we could not provide in person extra coaching classes and mid-day meal to students but provided them ration support during lockdown as many of the parents got financially affected.

MEDICAL AID & CLINICAL SERVICES

We were able to reach out and support 212 patients through our schemes like the Life saving Medical Aid, Medical Aid, Six Months Dialysis Support, Sustained Dialysis Support & Injection Support. Primary Health Care was rolled out through our charitable clinic. A total of 957 patients were serviced through our Clinics. We are grateful to Americares Indian Foundation and Medley Pharma for the regular donation of medicines. We also wish to thank Dr. Pokar, Dr. Shetty and Mrs. Shabana Kazi for contributing branded and generic medicine to help us in reaching the distressed patients attending our clinics. We are grateful to M/s.Allana Foundation, Nadeem Foundation, M/s.Nadiadwala Grandson Entertainment Pvt.Ltd, Tobaccowala Foundation for their generous donations for treatment of underprivileged patients.

RELIEF OF POVERTY & WOMEN EMPOWERMENT

We supported 330 families under the regular monthly Ration Support Scheme besides those served during lockdown. We are grateful to Mr. Farouk Ali Mahomed, Mr. Faisal Vahedna and several other individual donors who provided financial support. We also organized the Iftar Packets Distribution on behalf of some MESCO well-wishers, particularly Mr. Farouk Ali Mahomed.



A total of 500 packets containing 08 items were distributed from MESCO office, Mahim and Crescent English High School (Mumbra).

Three Sewing Machine Distribution programmes were held, one each in July, October and December of the year under report where a total of 148 sewing machines were awarded to empower women who had the necessary abilities to use these for gainful self-employment. We are grateful to M/s Nadiadwala Grandson Entertainment Pvt.Ltd., M/s.Wallem Ship Management Pvt.Ltd., Give India and several other individual donors who helped us give away the sewing machines to the rightful applicants.

Under Disaster management, we collaborated with Star foundation and Dardmand Jamiatul Khairiya to support Kokan cyclone affected people and donated Rs.170,000 for rehabilitation of cyclone affected people. We provided cemented sheets to 18 cyclone affected houses of Lonshi, Metkarni and Shekhadi villages of Raigard District.

It has been an eventful year and I wish to extend my gratitude to

my fellow Managing Committee Members, my Sub-Committee Members, Advisory Committee Members, my Staff, Volunteers and a sea of MESCO's donors and well-wishers, without all of you we might haven't been ready to achieve this level performance. YOUR Support and Prayers have ENCOURAGED us at MESCO to continue the Noble work. We thank each one of you and request you to continue your support in order that we will serve more people. We request you all to take care of yourself and your family and Stay Safe.

We pray that we are relieved of this COVID-19 pandemic disaster soon and seek the Blessings of the Al-Mighty for the whole mankind. We are there to Serve the Needy, so join hands with us and help Humanity.

Dr. Azhar Ali Qureishi Scholarship



EDUCATIONAL SUPPORT PROGRAMMES

32 million children between the age group of 6-17 years do not go to school in India. (Report by UNICEF)

Education is the path to prosperity for children and overall growth of the country. It allows us to find the meaning behind everything and helps to improve lives in a massive way. Education gives us an understanding of the world around us and offers us an opportunity to use that knowledge wisely. Irrespective of race, creed, and gender; Education makes it possible for people to stand out from different walks of life. Overall, education is the platform that makes it possible to defeat all barriers. MESCO has developed several Educational Schemes to enhance the society through Education, and curtail the dropout rate of students and encourage them to pursue their dreamed professions.

EDUCATIONAL AID (EA)

The main objective of Educational aid scholarship programme is to curtail the dropout ratio as well as to promote the means deprived students both at school level and college level. It enables to meet the part of their Educational cost and reasonably fair to lessen their burden to some extent. The statistic over the last four decades depicts the lower rate of dropout under the scheme and students are perseverance to achieve their goals. In the year **2020-21** the organization has assisted **2276 students** at School and **1063 students** at College Level under Educational Aid Scholarship programme.

It also works in the different sphere than the regular academic studies to promote those who go for some technical courses which has demand in the market. MESCO also extend its support to ITI students and also to the students who are into Short Term Vocational Courses (STVC). There is a huge market and scope for these skilled labors. Skill India is an initiative launched by the Government of India to promote skilled labour. India is a country today with 65% of its youth in the working age group. If ever there is a way to reap this demographic advantage, it has to be through skill development of the youth so that they add not only to their personal growth, but to the country's economic growth as well. In order to bridge that gap, MESCO encourages students who are least interested in academic studies to opt for such ITI and Vocational Courses which can provide them employment in a shorter duration of time. In the year 2020-21, the organization assisted 44 students under Educational Aid Technical (Scholarship) and also 57 students who took Short Term Vocational Courses like Electrician, Computer Hardware & Networking and Fashion Designing at the MES Vocational Training Centre.

EDUCATION ADOPTION SCHEME (EAS)

It is one the flagship programme of MESCO which is based on merit cum means where the academic excellence along with financial condition is taken into consideration. The main objective of this programme is to reach out to those students who excel in their studies but due to distressed and constrained financial conditions are forced to expel from their dream. This unique scheme is specially designed to cater to such students and provide them a platform to achieve their goal. The students are inducted from Std. VIII onwards, based on the last three years percentage after assessing the financial stability through home visit and then finally at Interview session with the student and parents by the Committee Members. In the year 2020-21, there were **510** students under the Education Adoption Scheme.

The organization believes in the holistic development of the students, in order to shape that belief multidimensional activities are carried out throughout the year like Personality Development Camp, Orientation Programme, Educational Programme, Aptitute Test, Engineering students Get-together, Graduating Students Get-together etc.



HIGH COST EDUCATION SCHEME (HCES)

21st century is the era of technological excellence and growth, which demands more professionals with innovative minds and idea that leads to the economic growth of our nation.

The primary aim of this scholarship programme is to search such talented competent mind with brighter academic background but are engulfed in the financial crises. Based on certain percentage criteria these students are inducted under High Cost Education Scheme and provide assistance to achieve professional degree.

The students are assisted under this scheme through a series of process like issue of forms on the basis of the academic results, home visit and interview session by Executive Committee Members. In the year **2020-21**, **217** students were under the High Cost Education Scheme (HCES). Those assisted under the scheme were **70** - Medical, **109**- Degree in Engineering, **7**-Diploma in Engineering, **10** - Business Management, **04**- Hotel Management, **02**- C.A., **07** - B.Ed & D.Ed, **03** - Graduation and **04**-Post Graduation and **01**- UPSC.

Pankaj got allied with MESCO in the year 2012 when he completed his Diploma in Engineering. He wanted to pursue Degree in Engineering. He was a meritorious student but was unable to afford the course fees.



His father was a tailor and mother was a homemaker. His father's monthly income was very low in which he was only able to feed his family. Pankaj's family was living in one of the slums of Goregaon. To manage his educational expenses he borrowed money from friends and relatives. His mother had to sell her jewelry as well to contribute to his fees. He struggled rigorously but never quit. After being inducted under HCES, his educational expenses were taken care by MESCO. With all his dedication and hard work he completed his Degree in Engineering with first class. Currently he is working as Fullstack Java Developer (I.T. Analyst) for T.C.S. since last 2 years. He is extremely grateful to MESCO and shares that,

MEDICAL SERVICES

MESCO Medical Aid Department aims to provide the best possible aid to all those who are financially challenged and struggling for their medical needs since 1976. Our aid ranges from Medical requirements like routine investigation, MRI, monthly medicines for Chronic Ailments, minor surgeries to Major surgeries, long term treatment, Dialysis etc. Under our Life Saving Medical Aid scheme we were fortunate to provide deserving patients with assistance for their severe medical/surgical conditions. Under our Medical Aid scheme, number of patients were supported for their basic requirements of medicines, investigations etc. The dialysis scheme enables us to reach out to the patients in desperate need of regular haemodialysis. Hence MESCO takes immense pleasure in helping patients to lead towards recovery every year and aims to continue with our efforts with the help of our benevolent donors in bringing the lives of the patients at ease.

this scheme, financial aid is provided to the poor and deserving patients from Pan India but being treated in Mumbai at the Municipal and State Govt.hospitals. The patients suffering from Cardiac ailment, Cochlear Implant transplant, Orthopaedic ailments, Hormone deficiency and other Chronic ailments are helped under this scheme. 59 patients were assisted under LSMA scheme in the year 2020-2021.

MEDICAL AID (MA / Formerly GMA) - Under this scheme, aid is provided to the poor and deserving patients who require help for medicines for Chronic Ailment, minor and day care surgeries like Cataract, diagnostic procedures like CT scan, MRI etc. Organisation assisted 88 patients under MA scheme in the year 2020-2021.

SIX MONTHS DIALYSIS SUPPORT — Kidney failure patients undergoing dialysis are assisted financially for their Six months dialysis cost. Keeping in mind the rise in COVID -19 cases and social distancing norms, telephonic registration was organised instead of form distribution process for the registration of the dialysis patient. A total of 49 patients were assisted under the 6 months dialysis support scheme in the year 2020-2021.

sustained dialysis support (SDS) – The scheme was started in the year 2012-13, where a life time financial assistance is being provided for the dialysis and Injection cost. These cases were selected from those patients who were under 6 months dialysis support. MESCO provided financial assistance under SDS scheme to 11 patients in the year 2020-2021.

SUSTAINED DIALYSIS DRUG SUPPORT (SDDS) – MESCO assisted 5 patients for the dialysis Injection cost for the life time, in the year 2020-2021.

MESCO trust feels fortunate to be able to save the life of a young child in crisis

~ Story of Sufiyan Ansari



13 years old Sufiyan Ansari male child living in slums of Bhiwandi got diagnosed with chronic renal failure in 2017. It was essential to perform haemodialysis thrice a week for him. He belonged to a family of seven members with father earning a sum of Rs.7000/- per month by working in a loom industry and elder brother earning a sum of Rs.5000/- p.m as an electrician. A single seating of Dialysis require Rs.800/- with a need of three dialysis per week. It was a matter of thought for the family struggling to compensate for both basic needs of bread — butter and medicines to save their young one. Fortunately he got selected by MESCO trust under 6 months dialysis scheme and received 6 months dialysis support from the organisation.

Our Organisation takes pride in being able to reach out to such genuinely needy and help them to take sigh of relief knowing that they are backed by us.

CLINICS DEPARTMENT

In the year 2020-21, due to the COVID-19 situation all over India, a complete lockdown was imposed, leading to a temporary closure of all our clinics. We restarted our primary healthcare dispensary located in Mumbra from 16th December 2020 with all the precautionary measures to serve the community. The total patient footfall was 957 till March 2021. We hope that more and more people will benefit from our services. We shall keep striving for the well-being of our beneficiaries.

MEDICAL CHECK-UP CAMP:

The Clinic's department had organized a Free Medical Check-up Camp in association with Vedant Hospital (Thane) and Navtarang Charitable Trust at MESCO's Medical Aid Dispensary, Mumbra on Sunday, 28th March 2021. Total 117 patients attended the camp, 25 patients were checked for electrocardiogram (ECG), 73 patients were checked for blood glucose level and 68 patients were checked for blood group. A total of 64 patients were examined by optometrists.

RELIEF OF POVERTY

RATION SUPPORT:

The basic need of a human being is food MESCO provides Ration Support to Widows, Deserted and very old people not having family. MESCO provides the following item mentioned below to **330** families every month:

Rice, Wheat, Sugar, Tur Dal, Masoor Dal, Oil, Tea Powder, Chana.

IFTAR PACKET DISTRIBUTION:

With the courtesy of our well wisher Mr. Farooque Ali Md., U.K., Mr. Faisal Vahedna, Mr. Ismail Patel and Mr. Mohammed Arif Mehtar we distributed Iftar packets to poor and needy fasting families. Last year MESCO has distributed 500 packets to poor and needy fasting Muslims in Mumbai and Thane area.

WOMEN EMPOWERMENT:

One of the income sources for Widows, Deserted and Poor ladies are to stitch cloth and earn money for their family. MESCO has been distributing Sewing Machines to widows, Destitute and Orphan ladies for their livelihood on the basis of their financial condition, trade test and interview for final decision. In the year 2020-2021 MESCO distributed **148** sewing machines.

Details of the Sewing Machine Distribution Program:

Due to lockdown Sewing Machine Distribution was held in MESCO office by taking all precautions like wearing mask and keeping beneficiaries at suitable distance.

The First cycle of Sewing Machine Distribution Programme was held on Friday **11**th **December 2020.** A total of **54** Sewing Machines were distributed on the occasion.

These Sewing Machines were sponsored by M/s. Nadiadwala Grandson Entertainment Pvt. Ltd., Give India and 8 individual donors.

The Second cycle of Sewing Machine Distribution Programme was held on Monday **11**th **January 2021**. A total of **22** Sewing Machines were distributed on the occasion.

These Sewing Machines were sponsored by M/s. Nadiadwala Grandson Entertainment Pvt. Ltd., Give India and 4 individual donors.

The Third cycle of Sewing Machine Distribution Programme was held on **Saturday 27**th **March 2021.** A total of **72** Sewing Machines were distributed on the occasion. These Sewing Machines were sponsored by M/s. Wallem Ship Management I. Pvt. Ltd., Give India and 21 individual donors.

A Life full of Crafting

~Story of Chanda Gopal

Mrs. Chanda Gopal 28 years old married woman had knowledge of stitching as she had learnt it from local stitching institute. She applied for sewing machine at MESCO. She used to live in a rented house in a humble neighborhood with her husband and 4 children. Her husband was a labourer at a construction site and was earning Rs.9000/-p.m. This was not enough to manage the expenses of her family. Chanda has four children. Her elder daughter Ms. Pooja was studying in 2nd Standard at BMC's Municipal School other children Ms. Payal and Ms. Deepa and Master Santosh were not admitted in school. Mrs. Chanda was going through major financial crises. To get rid of this issue she had also taken a private loan for managing house expenses and basic necessities of her children. She came to know about MESCO and its women empowerment scheme. With a great hope she applied for sewing machine at MESCO in 2017 and later on passing the trade test and interview, she received a sewing machine on 20th May 2017 and since then her life has changed. Initially she started taking orders for stitching from neighbors and gradually within couple of months she established a good rapport with Garment shops and slowly started receiving orders from them. Today she is able to support her family and living a happy and prosperous life. When we visited her house to know the impact of donating sewing machine. She shared that her life has changed and She did not have words to express her gratitude for MESCO. Now she is in a position to educate her children and also to support her family.

R.C. MAHIM MUNICIPAL SCHOOL

From the day MESCO adopted the school on 26th November 1997 under the partnership with the MCGM (Educ. Dept.), MESCO is trying its best to uplift the standard of R. C. Mahim Municipal School. It had total student strength of 800 in the reporting year. The SSC passing percentage has been 100 % in the current year.

Due to COVID-19 Pandemic and lockdown many parents lost their jobs, with the support of our donors, we were able to provide dry ration kits to 30 families and 60 iftar packets to deserving families during ramadan. Schools were not allowed to open therefore MESCO could not provide extra coaching classes and in person counselling to students. The impact of MESCO's intervention can be seen through the SSC results of last 24 years. We can see considerable improvement in the results and also many students who were about to discontinue their studies, are now continuing studies and achieving success in professional courses. Many students completed their graduation and now they are settled in their lives. It was MESCO who adopted RC Mahim School 24 years back with an intention to reduce dropout rate of underprivileged students. The organization provides them with quality education through free extra coaching classes and dry snacks. MESCO not only provides academic support but also nurtures students holistically through counselling, mentoring and involving them in extracurricular activities. Last 5 years' results can be seen below which are the fruitful efforts of MESCO.

A. BASIS OF ACCOUNTING:

- C. <u>PROPERTY PLANT EQUIPMENTS (PPE)</u>: PPE are stated at cost of acquisition, less accumulated depreciation. The cost of PPE includes the purchase cost of PPE and any other directly attributable costs of bringing the assets to their working condition for the intended use.
- **D.** <u>DEPRECIATION:</u> Depreciation is provided on the PPE under the written down Value method at the rates and in the manner prescribed by Income Tax Act, 1961 & has been charged to the Income and Expenditure Account.
- E. <u>INVESTMENTS</u>: Investments of the trust comprise of fixed deposits with banks and Mutual Funds stated at cost.
- **F. REVENUE RECOGNITION:** Donations are recognized on receipt basis. Donation received with a specific direction that they shall form part of the Corpus Fund of the Trust has been accounted accordingly. Interest income is accrued on a time proportion basis having regard to the amount outstanding and the rate applicable.
- **G.** Figures for the previous year have been regrouped and reclassified wherever necessary.


